Capital improvements are out for bid. Nine companies sent representatives. Moving dirt is the biggest cost. Expect person who solves the dirt removal will probably be the winner.

Building - Smartsheet is almost ready to go live to enable residents to apply for building permits online.

Common Areas – Ryan Beevers, chair

W6 has several parallel docks instead of perpendicular and that is creating spacing issues. Also, the depth there may impact whether spuds can be used. At B1, as docks rot and need to be replaces, they need to be moved to fit more slips. Committee has numbers back on multi-slip docks and will see if that is an option for residents who want slips at E3.

Dam Maintenance: Michael Watts and Roy Wehling, co-chairs – Fence is up. Waiting for paint. Water on backside of dam. Need to replace posts and cable next year. The gate down.
